Colony Pool Service Inc. is not responsible for lowering the pool water, it is your responsibility to have water level lowered to proper level (Solid cover: 3" below tile and Mesh cover 12" below tile) If you choose to have COLONY POOL SERVICE, INC lower your water, an additional fee will be applied. Dependent on supply parts and chemicals may vary from season to season and a compensator may be needed to winterize pool if one is not available and is needed. This also applies to any plugs that may need replacing. Appointment windows for your scheduled service is between the hours of 8a-6p. **Our technicians cannot guarantee a specific time or arrival. Cover and winterization plugs MUST be out on deck for technicians prior to service, technicians will not enter dwellings. Any anchors that may be stuck will be addressed after the closing rush.
